

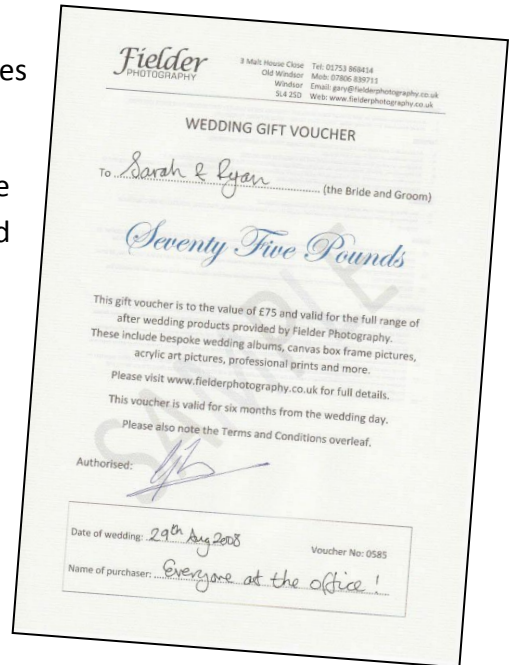

## Terms and Conditions

### General

1. It is your responsibility to read through these terms and conditions and be bound by them once you have placed your order.
2. In this document 'the Photographer' means Gary Fielder trading as Fielder Photography.
3. Gift vouchers are not refundable unless agreed prior to your wedding.
4. Gift vouchers are valid for six months from your wedding day.
5. The Bride and Groom may set a limit on the total value of gift vouchers that may be sold.

### Payments

6. All prices and packages are subject to reasonable change. Prices are adjusted periodically.
7. Bounced cheques shall incur a £25 charge.
8. Additional proofing disks (where applicable) will be charged at £15 per disk.
9. All Photobooks, proofs, prints, disks, etc may be collected in person from The Photographer in Old Windsor.
10. Where items are posted, The Photographer shall ensure sufficient postal insurance is included to cover loss or damage during transit. Reasonable postage and packing charges will be chargeable.

### Copyright

11. The Photographer shall retain all copyright to the images produced.
12. The Photographer reserves the right to use the images for any form of advertising, marketing, promotion or other legitimate purpose.

### Quality

13. Clients should be aware that colour dyes in photography may fade or discolour over a period of time if insufficient care is applied. All prints need to be kept at room temperature, stored in a box, away from heat and direct sunlight. Framed prints should not be located in direct sunlight.
14. Owing to photographic processing techniques it may not be possible to match exactly all colours as seen by the human eye. All print sizes are nominal.
15. The Photographer cannot guarantee that the colour of any proofs supplied and the colour of the final images will be exactly the same.

### Liability and Responsibility

16. The Photographer shall not be liable for degradation of images due to poor storage/handling, insufficient care or poor location.
17. The Photographer shall not be liable to the client for any failure, in whole or in part, to fulfil obligations where failure arises as a result of an event or circumstances beyond the Photographers control, which may include (but not be limited to) equipment failure, inclement weather, illness or injury.
18. All digital darkroom enhancements that significantly modify the image (e.g. removal of people) shall require written authorisation before reproduction is undertaken.
19. The Photographer shall not be responsible for image selection errors by the client whether for prints, Photobooks or other products. In the case of Photobooks a charge shall be made for re-design work.
20. You agree to hold the Photographer harmless from and against all liabilities, legal fees, damages, losses, costs and other expenses in relation to any claims or actions brought against the Photographer arising out of any breach by the client of these terms and conditions.
21. These terms and conditions may change at any time.
